Schools provide students with free instruction to fulfil the standard curriculum requirements and we want to assure you that all contributions are voluntary.

We deeply appreciate the support our families provide to ensure we can offer the best possible education and learning opportunities for our students. We thank you for your commitment to making annual voluntary contributions - schools rely heavily on them to provide the programs that families expect. We also thank you for contributing to our Building, Library and Equity funds, and for time spent volunteering on School Council committees and at school events.

In recent years parent contributions have been critical in ensuring:

- Expert input to our Social and Emotional Learning curriculum program through incursions and excursions
- Support for student participation in programs where families have limited capacity to pay through the school's own Equity Fund
- A vibrant and sustainable Instrumental Music Program
- Additional tutoring support for students beyond the Department Tutor Learning Initiative
- A host of excursions and incursion that complement and enhance the learning program
- Capacity to contribute to (e.g.) the grounds upgrade – planning currently underway
- Full Science room upgrade
- Renewal of Library carpet and fittings
- Major revitalisation of our school camp at Mirimbah
- Upgrades of ICT systems and hardware

Refunds

ONE PAGE OVERVIEW



FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
